Grants are available only to non-profit organizations that have obtained tax-exempt status under the United States Internal Revenue Code or are public entities which are tax exempt.

Grants are awarded in four categories – please see **Guidelines for 2024 Grant Applicants** for more information – preference is given to grants used for specific projects or equipment, rather than operating support.

The Wisconsin SFI limit on indirect cost reimbursement is 10% of the total grant (*NOTE: The indirect cost reimbursement limitation was instituted initially for 2017 grants.*)
